

What is the Okie TIPAC?

The Oklahoma Title Political Action Committee is a voluntary, non-profit, unincorporated association which helps elect candidates who have demonstrated support for the land title. **Okie TIPAC** supports only candidates for the Oklahoma legislature and for statewide office in Oklahoma.

How does Okie TIPAC operate?

It receives voluntary contributions from private individuals who are associated with the land title industry either through direct solicitation or fundraising events. Funds received are used to support candidates for office who are selected through a review of their voting records, political principles, and recommendations from local title people. Decisions regarding which candidates will receive contributions are made by the PAC Board of Directors.

I already pay my OLTA association dues. Why should I pay more?

Under state law, dues cannot be used for political contributions. These funds must be raised independently.

I don't like politics. Why should I get involved?

Whether you like it or not, you are involved in politics. Decisions about every aspect of the land title industry, including privacy issues, liens, property rights and possible deregulation of the industry are made by elected officials. **Okie TIPAC** works to help defeat adverse deregulation of the industry are made by elected officials. **Okie TIPAC** works to help defeat adverse legislation, while supporting pro-active initiatives which address problems facing the industry. **Okie TIPAC** plays a major role in these efforts.

Does Okie TIPAC support Democrats or Republicans?
